Strategic Alignment

The CHSD CoP being formed is itself one of the key strategic priorities in the draft CHSD strategy, which is currently with the NENC ICB Digital, Data and Technology executive team for review. Within the first three meetings of the CHSD CoP, we have explored 7 out of the 8 key elements in the strategic plan on a page which was shared in the previous summary paper (for CoP 2). We will explore the remaining area of funding opportunities in an upcoming CoP.

Great North Care Record (GNCR)

Jill Watson from the GNCR team presented updates to the CoP with a focus on community. Handouts of the Regional Update slide deck, Staff leaflet and Data Matrix have been distributed to CoP members – available on request to other interested stakeholders.

Follow-up discussions will take place in September around onboarding of community providers to GNCR and how the shared care record team might be able to support the CHS Digital agenda in line with the strategy.

Woundcare App Showcase

North Cumbria Integrated Care trust have successfully implemented Healthy IO's MinuteFul Digital Wound Management application, realizing excellent benefits. Just a sampling of these include: Workforce – Staff satisfaction, upskilling, empowerment, enabled transformation; Quality and Safety – Prevention of admissions and avoidable harm, improved outcomes including measurement of 30% of wounds healing within 12 weeks when managed through the app.

The CHSD CoP has made links between North Cumbria's team and a new group exploring development of woundcare guiding principles and collaborative work in the ICS. We will signpost interested stakeholders to the group for showcases and information as developments are made. Current CHS Digital Focus

The surveys referenced in the last CoP and summary have been launched and shared with community/digital team members at each of the 8 member trusts. The request is to complete and return these by the end of September for collation by the next group on 20th October. The focus of the surveys is on the following areas:

Systems baselining refresh – including EPR, e-rostering and scheduling; e-referrals; mobile working; ShCR; community digital apps

Digital Maturity Assessments – results and insights from DMAs where community teams completed these

Priorities – What's working well (possible showcases); What's not working well (challenges to help each other solve); What's currently in progress; What's planned for the future or desirable
