Presentation 1: Digital Diversity – It's all about digital! Rachael Forbister (Health Innovation NENC)

Rachael's inspiring presentation included information on a wide range of topics that could be put to excellent use within community health settings, such as:

- Exploring remote monitoring learning from how we use this for better health outcomes and alleviate General Practice pressures
- Approaches: Design Thinking and innovation design service
- Example areas and pathways of focus: UTI, LTCs, Medication reviews, Healthchecks, BP at home
- Outcomes, evaluation and resources;
- Other monitoring approaches and products e.g. Luscii, Whzan, Healthcall, AccuRx for community, Heidi Al for consultations, Vitalertor for falls prevention and many others

- Digital inclusion and champions

Presentation 2: Tech-Driven Solutions for a better Urgent & Emergency Care Service Nick Prentice (KPMG)

Nick provided an overview of the 12-week regional system review being undertaken at present, including a frailty-driven focus. Outputs will include a roadmap for improvement opportunities. There was opportunity for our CoP to provide feedback on key challenges, main technology challenges and key desired tech-enabled improvements. Angela Wood (NHSE) focused on Electronic Patient Records (EPRs) for this update, as part of the national 'one digital estate' (ODE) with a view to shaping a future investment proposal for EPRs. Please contact Angela with any feedback, ideas or queries in line with these 5 points:

- 1. Baseline digital maturity of all community provider EPRs (800 plus) including usability of EPRs
- 2. Optimisation of EPRs Improve current workflows / standardisation / data and interoperability
- 3. Commercially regulated market of EPR suppliers
- 4. Incentivisation of new market entrants/ EPR convergence
- 5. Explore options to extend the current EPR funding model to non-NHS providers (e.g. social enterprise, CICs & independent healthcare providers)
